

The Copernicus Legacy Relic Hunt Sweepstakes II

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR RECEIVE A PRIZE. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

SPONSOR: The Copernicus Legacy Relic Hunt Sweepstakes II (the "Sweepstakes") is sponsored by HarperCollins Children's Books, a division of HarperCollins Publishers L.L.C. ("Sponsor"), 195 Broadway, New York, NY 10007.

ELIGIBILITY: The Sweepstakes is open to all legal residents of the continental United States born before January 1, 2006, excluding employees and immediate family members of Sponsor, and its parents, subsidiaries, affiliates, assigns, advertising, promotional and fulfillment agents, attorneys, and other representatives and the persons with whom each of the above are domiciled. Offer void in Alaska, Hawaii, outside the United States, and wherever prohibited or restricted by law. Each entrant in the Sweepstakes must be the rightful owner or have authorized use of the email account indicated by the entrant's email address. In the event of a dispute concerning the identity of a prize winner submitting an entry, such prize winner will be deemed to be the person in whose name the email account is opened. The email account must be opened prior to 9:00:00 a.m. (ET) on October 7, 2014. Any person who has been selected as a prize winner and agreed to accept such prize in any sweepstakes or contest sponsored by Sponsor during the twelve (12) month period immediately preceding the start date of the Sweepstakes Period, as defined below, is ineligible to win a prize in this Sweepstakes.

HOW TO ENTER: The Sweepstakes begins at 9:00:00 AM Eastern Time ("ET") on October 7, 2014 and ends at 4:59:59 PM ET on February 7, 2015 ("Sweepstakes Period"). All Internet Entries must be received by 4:59:59 PM ET on February 7, 2015. To enter, visit www.thecopernicuslegacy.com (the "Web Site") and follow the on-screen instructions and complete and submit the Official Online Entry Form. You will be required to provide your (i) complete name, (ii) postal address including zip code, (iii) a valid email address, (iv) phone number including area code, (v) date of birth, and (vi) a valid email address of a parent or legal guardian if you are under 13 years of age and (vii) the name of your favorite character from the Copernicus Legacy (hereinafter, individually as an "Entry" and collectively as "Entries").

If you are an entrant under the age of 13, you may submit your Entry by only providing (i) date of birth, (ii) a valid e-mail address, (iii) phone number including area code, (iv) a valid email address of a parent or legal guardian, and (v) the name of your favorite character from the Copernicus Legacy. In the event an entrant selected as a potential prize winner is under the age of 13, such potential prize winner's parent or legal guardian will be contacted at the email address provided on the Entry and asked to provide parental consent to Sponsor within a designated time period. If parental consent is not received by Sponsor within the designated time period, the participant's Entry is void and an alternate potential prize winner will be selected in a random drawing from among all remaining eligible Entries received during the Sweepstakes Period.

Multiple entries are automatically disqualified; only the first Entry will be considered. **Use of any robotic, automatic or macro devices is not valid for Entry. Any Entry that is submitted with the use of a robotic, automated or macro device will be void.** All Entries become the property of the Sponsor and will not be acknowledged or returned.

SELECTION OF WINNERS/RANDOM DRAWING: Four (4) potential prize winners will be selected by a random drawing from among the eligible Entries during the Sweepstakes Period. Potential prize winners will be chosen by Sponsor no later than February 23, 2015. Potential prize winners will be notified by email and/or telephone and required to execute and return an Affidavit of Eligibility and Release (the "Affidavit") and a release of liability (the "Release"). Each prize winner's designated guest must also execute and return a Release. Eligibility, age and claims made by prize winners are subject to verification. If a potential prize winner fails to comply with these Official Rules and/or to submit the required documentation within the designated period, or if a prize winner notification is returned as undeliverable, the potential prize winner will be deemed to have forfeited the prize and the prize will be awarded to an alternate prize winner selected in a random drawing from among all remaining eligible Entries received during the Sweepstakes Period. If a potential prize winner is a minor, the potential prize winner's parent or legal guardian will be required to execute a Release, and any other necessary documents. FOUR (4) PRIZES: Each prize consists of (i) roundtrip economy class air transportation between the major commercial airport nearest prize winner's permanent residence and New York City, NY (airline carrier to be designated by Sponsor) for the prize winner and one (1) guest valued at up to \$2,000; (ii) one (1) night hotel accommodations (standard double occupancy room including taxes) at a hotel in New York City to be designated by Sponsor valued at up to \$1,000; (iii) attendance at the Copernicus Legacy Relic Hunt arranged by Sponsor for prize winner and guest, currently scheduled for June 20, 2015 (actual date subject to change and to be determined by Sponsor in its sole discretion); and (iv) attendance at Copernicus Legacy Author Event arranged by Sponsor for prize winner and guest. The total approximate retail value ("ARV") of each prize is up to \$3,000. The total ARV of all prizes is \$12,000. All prizes will be awarded, provided there are sufficient eligible Entries received. Prizes are non-transferable and cannot be sold or redeemed for cash. In the event a prize winner resides within 120 miles of New York City, NY, ground transportation may be awarded instead of air travel at the discretion of Sponsor, and the prize winner will not be entitled to any difference between air and ground transportation costs. Prize winners must travel on dates designated by Sponsor. In the event a prize winner cannot travel on dates designated by Sponsor, such prize winner will be disqualified and the prize will be awarded to an alternate prize winner in a random drawing from among all

Once travel is booked, travel times and dates cannot be changed unless by Sponsor in its sole discretion. Attendance at the Copernicus Legacy Relic Hunt and Copernicus Legacy Author Event portions of the prize have no cash or retail value. Guest must be 18 years of age or older as of the date of departure, unless the prize winner is the minor's parent or legal guardian.
